This past year over 900 unhoused and marginally housed individuals and families were served.

Veterans Matter: VM was started to house 35 local veterans and has now expended and housed over 4,000 unhoused veterans in 22 states thanks to the help of regular Americans, Veterans Groups, businesses and 20+ celebrities. Partnered with the VA and HUD for the HUD/VASH program, Veterans Matter has a 100% success rate housing veterans in a LONG-TERM VA program that has a 91% success rate in keeping veterans housed.
